

VectorClip3D/PatternSuperStore "Summer Contest" Official Rules

OFFERED ONLY IN THE UNITED STATES AND CANADA.

1. ELIGIBILITY: Open only to legal residents of the 50 United States, the District of Columbia and Canada who have reached the age of majority in the participant's jurisdiction of residence at time of entry. Winners will be notified by email, phone, postal mail and/or express mail at Sponsor's sole discretion.
